## 2025 SNUG Officer Elections

Spillman/Flex Northwest User Group (SNUG) board of directors officers are elected by the SNUG membership. Each board position shall have a regular term of office of 2 years, beginning on January 1st of the first year and ending on December 31st of the second year. The President, Secretary, and Treasurer are elected in even years, and the Vice President and Event Coordinator are elected in odd years.

The two positions that are up for election are Vice-president and Event Coordinator.

Each SNUG member agency gets one vote. If multiple votes for a single agency are submitted, the first vote submitted for that agency is the one that is counted. SNUG Secretary Beverly Crawford has temporarily been appointed Election Administrator.

The voting is open from 8/15/25 through 8/29/25, after which the Election Administrator will count the votes and distribute the results to the entire SNUG membership. Newly elected board members will take office on January 1st of the upcoming year (2026).


- We are planning for this to be a joint SNUG and IFLEX (Idaho Flex User Group) conference with breakout rooms for region-specific content (like StateLink).

We are going to stream the conference using Zoom. We will share the link to the Zoom conference on the snugonline.net Web page as the conference approaches.


## **Paying for SNUG Dues Online**
